

OSPF is offering in-person professional development training in the areas of suicide prevention, risk assessment, safety planning, and treatment for mental and behavioral health professionals.

Currently, registration is open for the following three training courses. We encourage you to register as soon as possible, as space is limited:

1. **Assessing and Managing Suicide Risk (AMSR)** training on December 8, 2022 in Cleveland, OH:
 - a. Assessing and Managing Suicide Risk (AMSR®) for Health and Behavioral Health Professionals Working in Outpatient Settings (AMSR-Outpatient) formulation model and helps clinicians feel confident navigating challenging conversations about suicide. AMSR offers key strategies for providing compassionate care to people at risk for suicide.

 - c. Participants who fully complete this training will also be eligible for 6.5 hours of continuing education credits from APA and NASW.
 - d. Cost: Training cost is completely covered through grant funds. There will only be a \$30 fee for food and beverages throughout the day.
2. **Collaborative Assessment and Management of Suicidality (CAMS)** training on December 9, 2022 in Columbus, OH:
 - a. CAMS is an evidenced-based treatment framework used to assess suicidality and specifically treat suicide risk. CAMS 3-part training provides mental health professionals (and other relevant professionals) with essential knowledge in using the CAMS framework to collaborate with patients in the treatment of their suicidal drivers.

 - c. 10.0 CE's will be awarded to Ohio social workers, counselors, and psychologists upon full completion of the course.
 - d. Cost: Training cost is completely covered through grant funds. There will only be a \$30 fee for food and beverages throughout the day.
3. **Counseling on Access to Lethal Means (CALM)** training on December 15, 2022 in Columbus, OH:
 - a. Reducing access to lethal means, such as firearms and medication, can determine whether a person at risk for suicide lives or dies. This course is about how to reduce access to the methods people use to take their lives. It covers who needs lethal means counseling and how to work with people at risk for suicide—and their families—to reduce access.
